OVERTIME PAY, SECTION TWO: COMPENSATION, PART C: CALL-BACK AND OVERTIME PAY, SECTION of the Employee Handbook of the City of Sweetwater, Tennessee, provides that:

2. Comp time may be accrued a maximum of 48 hours and beyond that limit any overtime will be compensated monetarily until such time as the accrued comp time is back below the limit allowed.
